### EXPLANATORY STATEMENT UNDER SECTION 102(1) OF THE COMPANIES ACT, 2013

### ITEM NO. 2 – RE-APPOINTMENT OF MR. SIDHARTHA PRADHAN AS INDEPENDENT TRUSTEE DIRECTOR OF THE COMPANY:

Mr. Sidhartha Pradhan is an independent director on the Board of the Company. He joined the Board of Directors of the Company on June 13, 2019 for the 1st term of 5 years for which will subsequently ended on June 12, 2024.

Mr. Pradhan joined the Indian Revenue Service in 1977 batch. 
