Options

Dividend (Regular, Annual and Quarterly Payout) and Growth

Dividend Option-

Under this Option, the Trustees reserve the right to declare dividend under the Scheme depending on the net distributable surplus available under the Option. It should, however, be noted that actual declaration of dividends and the frequency of distribution will depend, inter-alia, on the availability of distributable surplus and will be entirely at the discretion of the Trustees or any Committee authorised by them.

Growth Option-

All income earned and any realized profit in respect of a unit issued under that will continue to remain invested until repurchase and shall be deemed to have remained invested in the option itself and will be reflected in the NAV.

Both options will have a common portfolio.

The default option between the growth and dividend is growth. The default Dividend suboption will be Regular Dividend payout.

Pursuant to payment of dividend, if any, the NAV per unit of the dividend option of the Scheme would fall to the extent of the payout and statutory levy, if applicable. To the extent of payout of dividend, the NAV of dividend option will be different from growth option.

Minimum Application Amount

Minimum of Rs. 5,000 (Five Thousand) per application and in multiples of Re. 1/-thereafter

During the New Fund Offer period, Unit holders of other Schemes of Deutsche Mutual Fund shall have an option to switch in from other Schemes to this Scheme. However, the switch request should be accompanied with the Application Form/ Transaction Slip.

Redemption of Units

The Regulations requires that every close-end Scheme be mandatorily listed on a recognised stock exchange(s). The Fund intends to list the Scheme on the National Stock Exchange of India Limited (NSE). As the Scheme is being listed on NSE, investors will not be able to redeem their units during the tenor of the Scheme.

Redemption will be permitted by the Fund only on the maturity of the Scheme.

However units held in dematerialized form can be traded on the NSE.

Dematerialization

The Unitholders are given an Option to hold the units in physical form by way of an Account Statement or in Dematerialized ('Demat') form. Unit holders opting to hold the units in Demat form must provide their Demat Account details in the specified section of the application form. The Unit holder intending to hold the units in Demat form is required to have a beneficiary account with a Depository Participant (DP) (registered with NSDL / CDSL) and will be required to indicate in the application the DP's name, DP ID Number and the beneficiary account number of the applicant held with

In case the unit holders do not provide their Demat Account details, an Account Statement shall be sent to them. Such investors will not be able to trade on the stock exchange till their holdings are converted into Demat form.

No redemption/repurchase of units shall be allowed prior to the maturity of the Scheme. Unit holders wishing to exit may do so, through the Stock Exchange mode.

Load Structure

Investments by NRIs/FIIs/FPIs

Investments by NRIs/FIIs/FPIs are allowed on a full repatriation basis subject to RBI approvals, if any. However, the sale and solicitation of Units of the Fund is prohibited to citizens and residents of United States of America and any other jurisdiction which restricts or regulates the sale or solicitation of Indian securities to its citizens/residents or which jurisdiction could otherwise subject the AMC, its parent or affiliate companies, the Trustees, any employee or director of the AMC, Trustees or those of any affiliate company of the AMC to any reporting, licensing or registration requirements, in such jurisdiction.

Neither this SID nor the units have been registered in any jurisdiction outside India. The distribution of this SID in certain jurisdictions may be restricted or subject to registration requirements and, accordingly, persons who come into possession of this SID in such jurisdictions are required to inform themselves about, and to observe, any such restrictions. No person receiving a copy of this SID or any accompanying application form in such jurisdiction may treat this SID or such application form as constituting an invitation to them to subscribe for Units, nor should they in any event use any such application form, unless in the relevant jurisdiction such an invitation could lawfully be made to them and such application form could lawfully be used without compliance with any registration or other legal requirements.

Transfer

The units of the Scheme issued in Demat form are transferable in accordance with the provisions of SEBI (Depositories and Participants) Regulations, as may be amended from time to time.

Transfer would be only in favor of transferee(s) who are capable of holding units. The Fund will not be bound to recognize any other transfer. The delivery instructions for transfer of units will have to be lodged with the DP in requisite form as may be required from time to time and transfer will be given effect in accordance with such rules/regulations as may be in force governing transfer of securities in dematerialized mode.

Transparency

The first NAV shall be announced within 5 working days of from the date of allotment. The NAV of the Scheme thereafter will be calculated and declared on every business day on the AMFI website www.amfiindia.com and the Fund's website www.dws-india.com by 9. p.m on the same day. Also, NAV shall be published in atleast 2 daily newspapers. The complete portfolio shall also be published in 2 newspapers on a half yearly basis.

The monthly portfolio of the Schemes shall be available in a user-friendly and downloadable format on the website viz. www.dws-inida. com on or before the tenth day of succeeding month.

Liquidity

No redemption/repurchase of units shall be allowed prior to the maturity of the Scheme. Investors wishing to exit may do so through stock exchange mode.

Unit holders may please note that trading in units on the stock exchange(s) shall be suspended up to two working days prior to the record date for the purpose of dividend declaration.

Duration of the Scheme

The Scheme will be for duration of 1100 days from the date of allotment.

The Scheme will be fully redeemed at the end of the period. In case the maturity date or payout date happens to be a non-Business Day then the Applicable NAV for redemptions and switch outs shall be calculated immediately on the next Business Day.

However, the Scheme may be liquidated any time prior to the expiration, under the following circumstances:

- On the happening of any event which, in the opinion of the Trustees, requires the Scheme to be wound up.
- If seventy five per cent of the Unit holders pass a resolution that the Scheme be wound up.
- If SEBI so directs in the interest of the Unit holders.

KYC Policy

Investments in the Units of the Fund or any of its Schemes is / are subject to scrutiny and due diligence including, know your customer (KYC) due diligence as per (a) anti money laundering and other applicable laws, rules, regulations, circulars and byelaws notified and in force in India, from time to time ("Applicable Laws"); and (b) internal anti money laundering policies and procedures of the AMC ("AML Policies"). The AMC (including its agents) reserve(s) the right to freeze or terminate any folio which is not in accordance with or is otherwise found to be in breach of any Applicable Laws and / or internal AML Policies of the AMC, at any point of time, before or after the allocation of Units.

Further, in terms of SEBI Circular dated August 12, 2010, all new folios/accounts can only be opened if all investor related documents, including KYC documents etc. are available with the AMC and/or its Registrar.

Auto Switch Facility

This Fund will offer an auto switch facility from Liquid Schemes of Deutsche Mutual Fund to DWS Hybrid Fixed Term Fund Series 41 during the NFO period. However DeAM reserves the right to extend or limit the said facility on such terms and conditions as may be decided from time to time.

I. Introduction

A. RISK FACTORS

Standard Risk Factors

- Investment in Mutual Fund Units involves investment risks such as trading volumes, settlement risk, liquidity risk, default risk including the possible loss of principal.
- As the price / value / interest rates of the securities in which the Scheme invests fluctuates, the value of your investment in the Scheme may go up or down.
- Past performance of the Sponsor/AMC/Mutual Fund does not guarantee future performance of the Scheme.
- The name of the Scheme does not in any manner indicate either the quality of the Scheme or its future prospects and returns.
- The sponsor is not responsible or liable for any loss resulting from the operation of the Scheme beyond the initial contribution of Rs 1 lakh made by it towards setting up the Fund.
- The present Scheme is not a guaranteed or assured return Scheme.

Specific Risk Factors

Risk Factors Associated with Fixed Income and Money Market Instruments:

- a) The Scheme may invest in debt and debt related instruments, as may be permitted by SEBI, from time to time. Trading volumes, settlement periods and transfer procedures may restrict the liquidity of these investments. Different segments of Indian financial markets have different settlement periods and such periods may be extended significantly by unforeseen circumstances. The inability of the Scheme to make intended securities' purchases due to settlement problems could cause the Scheme to miss certain investment opportunities. The length of time for settlement may affect the Scheme in the event the Scheme has to meet an exceptionally large number of redemption requests. The Scheme will retain certain investments in cash or cash equivalents for its day-to-day liquidity requirements.
- A fundamental risk relating to all fixed income securities is a chance that an issuer will fail to make a principal and interest payment when due (credit risk). Issuers with higher credit risks typically offer higher yields for this added risk. Conversely, issuers with lower credit risk offer lower credit yields. Generally government securities are considered to be the safest in terms of the credit risk. Changes in financial conditions of an issuer, changes in economic and political conditions in general, or changes in economic or and political conditions specific to an issuer, all of which are factors that may have an adverse impact on a firms credit quality and security values. While it is the intent of the Investment Manager to invest primarily in highly rated debt securities, the Schemes may from time to time invest in higher yielding, lower rated securities. This is likely to enhance the degree of credit risk. Besides all other factors remaining the same, instruments with the longer tenure are perceived to have a higher credit risk Besides all other factors remaining the same, instruments with the longer tenure are perceived to have a higher credit risk. The Investment Manager will endeavour to manage credit risk through in-house credit analysis.
- c) All fixed income securities are also affected by changes in interest rates (interest rate risk). The prices of debt securities generally increase as interest rates decline and generally decrease as interest rates rise. Prices of long-term securities generally fluctuate more in response to interest rate changes than the short-term securities. The Debt markets can be volatile leading to the possibility of up or down movements in prices of fixed income securities and thus the possible movements in the NAV. The Scheme(s) may use various hedging products from time to time, as are available and permitted by SEBI, to attempt to reduce the impact of undue market volatility on the Scheme's portfolio.
- d) Debt securities may also be subject to price volatility due to factors such as market perception of the issuer and general market liquidity conditions (market risk).

- e) Lower rated or unrated securities are more likely to react to developments affecting the credit market than highly rated securities, which react primarily to movements in the general level of interest rates. Lower rated securities also tend to be more sensitive to economic conditions than higher rated securities. The Investment Manager will consider both credit risk and market risk in making investment decisions.
- f) The corporate debt market is relatively illiquid vis-à-vis the government securities market. Even though the government securities market is more liquid compared to that of other debt instruments, on occasions, there could be difficulties in transacting in the market due to extreme volatility or unusual constriction in market volumes or on occasions when an unusually large transaction has to be put through.
- g) Zero coupon or deep discount bonds are debt obligations that do not entitle the holder to any periodic payment of interest prior to maturity or a specified date when the securities begin paying current interest and therefore, are generally issued and traded at a discount to their face values. The discount depends on the time remaining until maturity or the date when securities begin paying current interest. It also varies depending on the prevailing interest rates, liquidity of the security and the perceived credit risk of the Issuer. The market prices of zero coupon securities are generally more volatile than the market prices of securities that pay interest periodically and are likely to respond to changes in interest rates to a greater degree than other coupon bearing securities having similar maturities and credit quality.
- h) Apart from normal credit risk, zero coupon bonds carry an additional risk, unlike bonds that pay interest throughout the period to maturity, zero coupon instruments/deferred interest bonds typically would not realise any cash until maturity or till the time interest payment on the bonds commences. If the issuer defaults, the Scheme may not obtain any return on its investment.
- i) The Scheme may invest in securities which are not quoted on a stock exchange ("unlisted securities") which in general are subject to greater price fluctuations, less liquidity and greater risk than those which are traded in the open market. Unlisted securities may lack a liquid secondary market, and there can be no assurance that the Scheme will realise its investments in unlisted securities at a fair market value, if sold in the secondary market.
- j) There have been times in the past, when settlements have been unable to keep pace with the volume of securities transactions, making it difficult to conduct further transactions. Delays or other problems in settlement of transactions could result in temporary periods when the assets of the Scheme are not invested and no return is earned thereon.
- k) Prepayment Risk: Certain fixed income securities give an issuer the right to call back its securities before their maturity date, in periods of declining interest rates. The possibility of such prepayment may force the Fund to reinvest the proceeds of such investments in securities offering lower yields, resulting in lower interest income for the Fund.
- Neinvestment Risk: This risk refers to the interest rate levels at which cash flows received from the securities in the scheme are reinvested. The additional income from reinvestment is the "interest on interest" component. The risk is that the rate at which interim cash flows can be reinvested may be lower than that originally assumed.
- m) Settlement Risk: The inability of the Scheme to make intended securities purchases due to settlement problems could cause the Scheme to miss certain investment opportunities. By the same rationale, the inability to sell securities held in the Scheme's portfolio due to the extraneous factors that may impact liquidity would result at times, in potential losses to the Scheme, in case of a subsequent decline in the value of securities held in the Scheme's portfolio.
- Regulatory Risk: Changes in government policy in general and changes in tax benefits applicable to Mutual Funds may impact the returns to investors in the Scheme.
- The value of the Scheme's investments may be affected generally by factors affecting capital markets, such as interest rates, currency exchange rates, foreign investment, changes

- in government policy, taxation and political, economic or other developments. Consequently, the net asset value of the Scheme may fluctuate and the value of the Scheme's Units may go down or up. Past performance of the sponsors is not necessarily indicative of future performance of the Scheme.
- p) Money Market instruments are instruments that are generally have maturity of less than one year. The NAV of the Scheme's units will be affected by the changes in the level of interest rates
- q) Investments in money market instruments and debt instruments involve credit risk commensurate with short term rating of the issuers. Further, Commercial Papers are an unsecured money market instrument issued in the form of a promissory note.

Risk Factors Associated with investment in equity and equity related Instruments:

- Subject to the stated investment objectives, the Scheme proposes to invest in equity and equity related securities. Trading volumes, settlement periods and transfer procedures may restrict the liquidity of these investments. Different segments of Indian financial markets have different settlement periods and such periods may be extended significantly by unforeseen circumstances. The inability of the Scheme to make intended securities' purchases due to settlement problems could cause the Scheme to miss certain investment opportunities. Delays or other problems in settlement of transactions could result in temporary periods when the assets of the Scheme are not invested and no return is earned thereon. The inability to sell securities held in the Scheme's portfolio, due to the absence of a liquid secondary market, would result at times, in potential losses to the Scheme, should there be a subsequent decline in the value of securities held in the Scheme's portfolio.
- b) Equity securities and equity related securities are volatile and prone to price fluctuations on a daily basis.
- c) The performance and the value of the Scheme's investments may be affected by factors affecting the securities markets such as price and volume volatility in the capital markets, currency exchange rates, changes in law / policies of the Government, taxation laws and political, economic or other developments which may have an adverse bearing on individual securities, a specific sector or all sectors. Consequently, the NAV of the Units may be affected.
- d) The liquidity and valuation of the Scheme's investments due to its holdings of unlisted securities may be affected if they have to be sold prior to their target date of divestment.
- e) The Scheme may invest in securities which are not quoted on a stock exchange ("unlisted securities") which in general are subject to greater price fluctuations, less liquidity and greater risk than those which are traded in the open market. Unlisted securities may lack a liquid secondary market and there can be no assurance that the Scheme will realize its investments in unlisted securities at a fair value.
- f) The Scheme may also use various derivatives and hedging products from time to time, as would be available and permitted by SEBI, in an attempt to protect the value of the portfolio and enhance Unitholders' interest. The risks associated with dealing in Derivatives trading are given below under "Risk factors associated with trading in derivatives".

Risk factors associated with Trading in Derivatives:

- a) Derivatives are high risk, high return instruments as they may be highly leveraged. A small price movement in the underlying security could have a large impact on their value and may also result in a loss.
- b) Derivative products are leveraged instruments and can provide disproportionate gains as well as disproportionate losses to the investor. Execution of such strategies depends upon the ability of the fund manager to identify such opportunities. Identification and execution of the strategies to be pursued by the fund manager involve uncertainty and decision of fund manager may not always be profitable. No assurance can be given that the fund manager will be able to identify or execute such strategies.
- The risks associated with the use of derivatives are different from or possibly greater than, the risks associated with investing

- directly in the underlying securities and other traditional investments.
- d) The Scheme may find it difficult or impossible to execute derivative transactions in certain circumstances. For example, when there are insufficient bids or suspension of trading due to price limits or circuit breakers / filters, the Scheme may face a liquidity issue.
- e) The relevant stock exchange may impose restrictions on exercise of options and may also restrict the exercise of options at certain times in specified circumstances.
- f) The risk of loss in trading futures contracts can be substantial, because of the low margin deposits required, the extremely high degree of leverage involved in futures pricing and the potential high volatility of the futures markets.
- g) The Fund may use derivative instruments like Stock Index Futures, Interest Rate Swaps, Forward Rate Agreements, Interest Rate Future or other derivatives.
- h) Credit Risk: This occurs when a counterparty defaults on a transaction before settlement and therefore, the Scheme is compelled to negotiate with another counterparty at the then prevailing (possibly unfavorable) market price, in order to maintain the validity of the hedge.
- Market risk: This is where the derivatives cannot be sold (unwound) or purchased at prices that reflect the underlying assets, rates and indices...
- j) Model Risk: This is the risk of mis-pricing or improper valuation of derivatives
- k) Basis Risk: This is when the instrument used as a hedge does not match the movement in the instrument / underlying asset being hedged. The risks may be inter-related also; for e.g. interest rate movements can affect equity prices, which could influence specific issuer / industry assets.
- Floating Leg Risk: The fund pays the daily compounded rate.
 In practice however there can be a difference in the actual rate at which money is lent in the call market and the benchmark, which appears and is used. The risk is to the extent that returns are limited for the investors in case of extreme movement in call rates
- m) In case of a received position in a call rate linked interest rate swaps (OIS), the fund pays the daily compounded rate. In practice however there can be a difference in the actual rate at which money is lent in the call market and the benchmark call rate, which is used in the swap calculations. The risk is to the extent that returns may be impacted to the investors in case of extreme movement in call rates.
- It may be mentioned here that the guidelines issued by Reserve Bank of India from time to time for forward rate agreements and interest rate swaps and other derivative products would be adhered to.

Please refer to page 13-14 of this document for an illustration on potential loss which could be caused by investments in derivative instruments.

Risk Factors associated with Listing of Units

- a) Trading in the Units of the Scheme on the Exchange may be halted because of market conditions or for reasons in view of the Exchange Authorities or SEBI, rendering trading in the Units of the Scheme inadvisable. In addition, trading of the Units of the Scheme is subject to trading halts caused by extraordinary market volatility and pursuant to the Stock Exchange's/market regulator's 'circuit filter' rules. There can be no assurance that the requirements of the concerned Stock Exchange necessary to maintain the listing of the units of the Scheme will remain unchanged.
- b) Unit holders may find it difficult or uneconomical to liquidate their investments at any particular time. For the units listed on the exchange, it is possible that the market price at which the units are traded may be at a discount to the NAV of such Units. As a result, a Unit holder must be prepared to hold the units until the maturity of the Scheme.
- c) Although the Units of the Scheme will be listed on the Stock Exchange, there can be no assurance that an active secondary market will develop or be maintained.

- d) The Units of the Scheme may trade at a significant discount or premium on the Stock Exchange. The NAV of the Scheme will fluctuate in accordance with market supply and demand for the units of the Scheme as well as be affected by changes in NAV.
- e) Regulatory Risk: Any changes in trading regulations by the Stock Exchange or SEBI among other things may also result in a wider premium/ discount to the NAV of the Scheme. Although the Units are proposed to be listed on the Stock Exchange, the AMC and the Trustees will not be liable for any loss suffered by investors due to delay in listing of units of the Scheme on the Stock Exchange or due to connectivity problems with the depositories due to the occurrence of any event beyond their control.

B. REQUIREMENT OF MINIMUM INVESTORS IN THE SCHEME / PLAN

The Scheme/ individual Plan under the Scheme shall have a minimum of 20 investors and no single investor shall account for more than 25% of the corpus of the Scheme/Plan. These conditions will be complied with, immediately after the close of the NFO itself i.e. at the time of allotment. In case of non-fulfillment with the condition of minimum 20 investors, the Scheme/Plan shall be wound up in accordance with Regulation 39 (2) (c) of SEBI (MF) Regulations automatically without any reference from SEBI. In case of non-fulfillment with the condition of 25% holding by a single investor on the date of allotment, the applications to the extent of exposure in excess of the stipulated 25% limit would be liable to be rejected and the allotment would be effective only to the extent of 25% of the corpus collected. Consequently, such exposure over 25% limits will lead to refund within 5 working days from the date of closure of the New Fund Offer.

C. SPECIAL CONSIDERATIONS

- a) Mutual funds being vehicles of securities investments are subject to market and other risks and there can be no guarantee against loss resulting from investing in the Scheme. The various factors which impact the value of the Scheme's investments include, but are not limited to, fluctuations in the equity and bond markets, fluctuations in interest rates, prevailing political and economic environment, changes in government policy, factors specific to the issuer of the securities, tax laws, liquidity of the underlying instruments, settlement periods, trading volumes, etc.
- b) The past performance of the mutual funds managed by the Sponsors and their affiliates / associates is not indicative of the future performance of the Scheme.
- Investment decisions made by the AMC / Investment Manager may not always be profitable.
- d) The Scheme in accordance with the Regulations can invest in securities which are not quoted on a stock exchange ("unlisted securities") which in general are subject to greater price fluctuations, less liquidity and greater risk than those which are traded in the open market. Unlisted securities may lack a liquid secondary market and there can be no assurance that the Scheme will realise its investments in unlisted securities at a fair value.
- e) Different types of securities in which the Scheme would invest as given in the Scheme Information Document carry different levels and types of risk. Accordingly the Scheme's risk may increase or decrease depending upon its investment pattern.
- f) The Fund may, where necessary, appoint other intermediaries of repute as advisors, custodian / sub-custodians etc. for managing and administering such investments. The appointment of such intermediaries shall be in accordance with the applicable requirements of SEBI and within the permissible ceilings of expenses. The fees and expenses would illustratively include, besides the investment management fees, custody fees and costs, fees of appointed advisors and sub-managers, transaction costs and overseas regulatory costs.
- g) As liquidity of the Scheme's investments could, at times, be restricted by trading volumes and settlement periods, the time taken by the Mutual Fund for redemption of Units may be significant in the event of an inordinately large number of redemption requests or of a restructuring of the Scheme's

- portfolio. In view of this, the Trustee has the right, in its sole discretion to limit redemptions (including suspending redemption) under certain circumstances, as described under the section titled "Right to Limit Redemptions".
- h) It is compulsory for mutual funds to dematerialise their holdings in certain notified securities / companies.
- Certain focus areas are already enjoying favorable tax treatment by Government of India. Other focus areas that the Scheme invests in may also receive favorable tax treatment. If these tax benefits are removed or amended, it is possible that the changes may have a material adverse impact on the companies' revenue and earnings.
- j) As the liquidity of the Scheme's investments may sometimes be restricted by trading volumes and settlement periods, the time taken by the Fund for redemption of Units may be significant in the event of an inordinately large number of redemption requests or of a restructuring of the Scheme's portfolio. In view of this, the Trustee has the right, in its sole discretion, to limit redemptions under certain circumstances.
- k) Neither this SID nor the units have been registered in any jurisdiction outside India. The distribution of this SID in certain jurisdictions may be restricted or subject to registration requirements and, accordingly, persons who come into possession of this SID in such jurisdictions are required to inform themselves about, and to observe, any such restrictions. No person receiving a copy of this SID or any accompanying application form in such jurisdiction may treat this SID or such application form as constituting an invitation to them to subscribe for Units, nor should they in any event use any such application form, unless in the relevant jurisdiction such an invitation could lawfully be made to them and such application form could lawfully be used without compliance with any registration or other legal requirements.
- The Scheme may be narrowly focused among sectors and therefore, changes in a particular industry can have substantial impact on the Scheme's NAV.

Investors are advised to study the terms of the offer carefully before investing in the Scheme, and to retain this SID for future reference.

Compliance under Foreign Account Tax Compliance Act (FATCA) regulations

The Internal Revenue Service (IRS) of the United States of America introduced the Foreign Account Tax Compliance Act (FATCA) Regulations in the year 2010. FATCA regulations (whether proposed, temporary or final), including any subsequent amendments, any agreements signed by the US government to implement these regulations, and administrative guidance promulgated there under (or which may be promulgated in the future) impose or may impose a number of obligations on financial institutions. The intention of FATCA is that details of U.S. investors holding assets outside the US will be reported by financial institutions to the United States Internal Revenue Service (IRS), as a safeguard against U.S. tax evasion. As a result of FATCA, and to discourage non-U.S. financial institutions from staying outside this regime, financial institutions that do not enter and comply with the regime will be subject to a 30% penalty withholding tax with respect to certain U.S. source income (including dividends) and gross proceeds from the sale or other disposal of property that can produce U.S. source income. Sections 1471 through 1474 of the U.S. Internal Revenue Code impose a 30% withholding tax on certain payments to a foreign financial institution ("FFI") if that FFI is not compliant with FATCA

The Mutual Fund is a FFI and thus, subject to FATCA. Beginning 1 July 2014, this withholding tax applies to payments to the Fund that constitute interest, dividends and other types of income from U.S. sources (such as dividends paid by a U.S. corporation) and beginning on 1 January 2017, this withholding tax is extended to the proceeds received from the sale or disposition of assets that give rise to U.S. source dividend or interest payments. These FATCA withholding taxes may be imposed on payments to the Mutual Fund unless (i) the Mutual Fund becomes FATCA compliant pursuant to the provisions of FATCA and the relevant regulations, notices and announcements issued there under, or (ii) the Mutual Fund is subject to an appropriate Inter-governmental Agreement ("IGA") to improve international tax compliance and to implement FATCA. India has

agreed "in substance" with IRS for Inter Governmental Agreement Model 1 (IGA-1) on 11th April 2014. Under IGA-1 model, Mutual Funds are required to institute a process to identify US Person investors and report the same. The formal IGA is yet to be signed by the Indian government.

Pursuant to the above, the Applicant agrees and undertakes to provide such information and/or documentation concerning itself and its direct and indirect beneficial owners (if any), as and when requested by the Mutual Fund or the AMC, at its sole discretion, determines it necessary or advisable for the Mutual Fund / AMC to comply with its obligations under FATCA. The AMC may at its own discretion, decide to implement any of the 2 options mentioned below

Option #1 [Compulsory closure- if documents / info not received within 1 year of signing of IGA]

The Applicant acknowledges that if the Applicant does not timely provide the requested information and/or documentation, as applicable, within 1 (one) year from the date of signing of the IGA, the Mutual Fund/ AMC may, at its sole discretion and in addition to all other remedies available at law or in equity, immediately or at such other time or times redeem all or a portion of the Applicant's subscription, prohibit in whole or part the Applicant from participating in additional subscription and/or deduct from the Applicant's subscription and retain amounts sufficient to indemnify and hold harmless the Mutual Fund/ AMC, or any other subscriber/ investor, or any partner, member, shareholder, director, manager, officer, employee, delegate, agent, affiliate, executor, heir, assign, successor or other legal representative of the Mutual Fund/AMC, from any and all withholding taxes, interest, penalties and other losses or liabilities suffered by any such person on account of Applicant's failure to timely provide the requested information and/ or documentation.

Option #2 [Compulsory reporting- if documents / info not received within 90 days from date of subscription]

The Applicant acknowledges that if the Applicant does not timely provide the requested information and/or documentation, as applicable, within 90 (ninety) days from the date of subscription, the Mutual Fund/ AMC may, at its sole discretion classify the account as a US Account and report the details of the account to the US Authorities. The Applicant agrees and undertakes to indemnify and hold harmless the Mutual Fund/ AMC, or any other subscriber/investor, or any partner, member, shareholder, director, manager, officer, employee, delegate, agent, affiliate, executor, heir, assign, successor or other legal representative of the Mutual Fund/AMC, from any and all withholding taxes, interest, penalties and other losses or liabilities suffered by any such person on account of Applicant's failure to timely provide the requested information and/or documentation and the consequent reporting by the Mutual Fund/AMC.

The Applicant further acknowledges that the Mutual Fund/ AMC, will determine in its sole discretion, whether and how to comply with the FATCA provisions in terms of timely collection of information and/or documentation.

The Applicant acknowledges and agrees that it shall have no claim against the Mutual Fund/ AMC or any other subscriber/investor, or any partner, member, shareholder, director, manager, officer, employee, delegate, agent, affiliate, executor, heir, assign, successor or other legal representative of the AMC, for any damages or liabilities attributable to any FATCA compliance carried out by the Mutual Fund/AMC.

Applicants are required to refer to the "FATCA information" section in the application and mandatorily fill/sign off on the same. Applications without this information / declaration being filled/signed off will be deemed as incomplete and are liable to be rejected. Investors are requested to note that the contents of the information to be provided / declaration in the application form may undergo a change on receipt of communication / guidelines from AMFI/SEBI on signing of the IGA.

Where the portfolio is not rebalanced within 30 Days, justification for the same shall be placed before the Investment Review Committee and reasons for the same shall be recorded in writing.

The Investment Review Committee shall then decide on the course of action. However, at all times, the portfolio will adhere to the overall investment objective of the Scheme.

Debt Markets in India

The Indian debt market, one of the largest in Asia, is developing rapidly buoyed by a multitude of factors including new instruments, increased liquidity, deregulation of interest rates and improved settlement systems. The major players in the Indian debt markets today are banks, financial institutions, insurance companies, pension funds, provident funds and mutual funds. The instruments in the market can be broadly categorized as those issued by corporates, banks, financial institutions and those issued by state/central governments. The main risks associated with any investments are credit risk, interest rate risk and liquidity risk. While corporate papers carry credit risk due to changing business conditions, government securities are perceived to have zero credit risk. Interest rate risk is present in all debt securities and changes in interest rates depend on a variety of macroeconomic factors. The largest segment of the Indian Debt market consists of the Government of India securities where the daily trading volume is in excess of Rs. 2000 crores, with instrument tenors ranging from short dated Treasury Bills to long dated securities extending upto 30 years. The corporate bond market, though relatively less liquid, is also fast developing with an increased participation from the banks, Financial Institutions, mutual funds, provident funds, insurance companies and corporate treasuries. Also there are a large number of instruments available like MIBOR linked bonds, commercial papers, certificate of deposits and medium to long dated fixed and floating rate bonds. The yield curve usually tends to be positive sloping i.e. yield of shorter dated securities being lower than that of longer dated ones.

The money markets in India essentially consist of call money market (i.e. market for overnight and term money between banks and institutions), repo transactions (temporary sale with an agreement to buy back the securities at a future date at specified price), CBLO, commercial papers (CPs, short term unsecured promissory note, generally issued by corporates), certificate of deposits (CDs, issued by banks) and Treasury Bills (issued by RBI). A predominantly institutional market, the key money market players are banks, financial institutions, insurance companies, mutual funds, primary dealers and corporates.

The various instruments currently available for investments are:

The actual yields will, however, vary in line with general levels of interest rates and debt / money market conditions prevailing from time to time.

D. SCHEME'S INVESTMENTS

The Scheme will invest in debt and money market instruments. The Scheme will also invest in equity and equity related instruments including exchange traded options and futures. It retains the flexibility to invest across all the securities in the debt and money markets. From time to time the Scheme may also hold cash.

Debt securities and Money Market Instruments will include but will not be limited to:-

 Securities created and issued by the Central and State Governments and / or repos / reverse repos in such Government Securities as may be permitted by RBI (including but not limited to coupon bearing bonds, zero coupon bonds and treasury bills)

[§] As per Regulation 2(o) of SEBI (MF) Regulations, 1996, "money market instruments" includes commercial papers, commercial bills, treasury bills, Government securities having an unexpired maturity up to one year, call or notice money, certificate of deposit, usance bills, and any other like instruments as specified by the Reserve Bank of India from time to time.

- Securities guaranteed by the Central and State Governments (including but not limited to coupon bearing bonds, zero coupon bonds and treasury bills)
- Debt securities of domestic Government agencies and statutory bodies, which may or may not carry a Central / State Government guarantee
- d) Corporate debt and securities (of both public and private sector undertakings) including Bonds, Debentures, Notes, Scrips, etc.
- Debt securities of banks (both public and private sector) and development financial institutions
- f) Non-convertible part of convertible debentures
- g) Money market instruments as permitted by SEBI / RBI, call money market or in alternative investments for the call money market as may be provided by RBI to meet the liquidity requirements and as defined under The SEBI (Mutual Funds) Regulations, 1996.
- h) Certificate of Deposits (CDs)
- Fixed Income Derivative instruments like Exchange Traded Interest Rate Futures, Interest Rate Swaps, Forward Rate Agreements and such other derivative instruments as permitted by SEBI/ RBI
- j) Any other like instruments as may be permitted by RBI / SEBI / such other Regulatory Authority from time to time.

The Scheme could invest in Fixed/Floating rate Securities issued by government, quasi government entities, corporate issuers, structured notes and multilateral agencies. Structured Obligation transactions, usually incorporate some form of credit enhancement / payment mechanism which isolate cash flows to be prioritized for repayment on the security, thus enhance credit quality for the investor. The securities mentioned above could be listed or unlisted, privately placed, secured or unsecured, rated and of any maturity, as enabled under SEBI Regulations/ circulars/ RBI. The securities may be acquired from primary market, secondary market operations, private placement or negotiated deals. Pending deployment of the funds collected in the Scheme, funds of the Scheme can be parked in Short Term Deposits of Scheduled Commercial Banks subject to compliance with the SEBI Circular No. SEBI/IMD/CIR No.9/20306/03 dated November 12, 2003, SEBI Circular No. SEBI/ IMD/Cir No.1/91171/07 dated April 16, 2007, SEBI and Clause 8 of Seventh Schedule of Mutual Funds Regulations, 1996 and SEBI Circular No. SEBI/IMD/Cir No.1/91171/07 dated April 16, 2007.

The Scheme may invest in other debt Schemes managed by the AMC or in the debt Schemes of any other Mutual Funds, provided it is in conformity to the investment objectives of the Scheme and in terms of the prevailing Regulations. As per the Regulations, no investment management fees will be charged for such investments and the aggregate inter Scheme investment made by all Schemes of Deutsche Mutual Fund or in the Schemes under the management of other asset management companies shall not exceed 5% of the net asset value of the Deutsche Mutual Fund.

The Scheme does not intend to enter into underwriting obligations. However, if the Scheme does enter into an underwriting agreement, it would do so after complying with the Regulations and with the requisite approval of the Board of the AMC / Trustee.

The AMC will not invest in any of the Schemes unless full disclosure of its intention to invest has been made in the SID and that the AMC will not charge any fees on such investments.

E. INVESTMENT STRATEGY

The Scheme endeavors to preserve capital by investing in fixed income securities; and generate capital appreciation by investing in equity and equity related instruments. 5% to 25% of net assets would be invested in equity and equity linked instruments and the balance net assets would be invested into debt securities and money market instruments.

Fixed Income:

The fixed income portfolio will consist of

 A pool of investment grade rated fixed income securities maturing in line with the tenure of the fund This portfolio would comprise mostly Hold to Maturity (HTM) securities.

The Fund Management team endeavors to meet the investment objective whilst maintaining a balance between safety and return on investments. The Scheme shall be actively managed and the Fund Management team may endeavor to generate returns whilst moderating credit and interest rate risk. The Fund Manager shall formulate a view of the interest rate movement based on various parameters of the Indian economy, as well as developments in global markets. The Investment Manager may try to leverage its international resource base to understand the global economic and interest rate environment. Deutsche Asset Management (DeAM) has a proprietary research platform, accessed by DeAM investment professionals across the globe. Research inputs along with discussions with colleagues across the globe on the global economic environment provide the fund management team with a global perspective.

Investment views/decisions inter alia may be taken on the basis of the following parameters:

- Returns offered relative to alternative investment opportunities.
- Prevailing interest rate scenario
- Quality of the security/instrument (including the financial health of the issuer)
- Maturity profile of the instrument
- Any other factors considered relevant in the opinion of the Fund Management team.

The Scheme may also use derivatives to reduce the volatility of the portfolio and/or to enhance the portfolio returns. The Scheme may try to identify securities that yield relative value over others for similar risk and liquidity level. Various analytical tools like yield curve analysis, spreads between asset classes, horizon returns, forward implied interest rates, may be deployed to evaluate various investment options.

Equity strategy:

A top down and bottom up approach will be used to invest in equity and equity related instruments. Investments will be pursued in selected sectors based on the Investment team's analysis of business cycles, regulatory reforms, competitive advantage etc. Selective stock picking will be done from these sectors. The fund manager in selecting scrips will focus on the fundamentals of the business, the industry structure, the quality of management, sensitivity to economic factors, the financial strength of the company and the key earnings drivers. The Scheme may invest in unlisted and / or privately placed securities subject to the regulatory limits.

Equity derivatives strategy:

The equity derivatives strategy would endeavor to provide exposure to equities through mainly derivatives, i.e exchange traded options and futures. The equity derivatives strategy shall endeavor to provide the portfolio with participation in the underlying equity index. The participation rate would depend on the prevailing prices of the options. The total exposure related to option premium paid will not exceed 20% of the net assets of the Scheme at the time of investment. If due to market movements, the value of options appreciates/ depreciates resulting in breach of the limit of 20%, the fund manager may or may not rebalance the portfolio. However, if the fund manager sells the option before expiry of the contract, the reinvestment, if any, would be subject to the maximum 20% limit on options premium.

Additional Disclosures for close ended debt Funds pursuant to SEBI Circular dated August, 01, 2011

a) Credit Evaluation Policy

We maintain a 'fixed income' universe of approved securities for all the fixed income portfolios.

Credits are researched through a credit research exercise which includes inter-alia, meeting with borrower (usually includes the finance team and senior management/ personnel in decision making roles) and the rating agencies (could also be a concall) to understand the business / financial and business prospects / credit outlook. In addition, financial analysis is carried based on past performance.

Emphasis is also laid on reviewing the non financial aspects such as promoter track-record, audit quality and market intelligence.

All names are researched by the analyst and discussed with the head - fixed income to be approved and included in the Universe. The IRC also reviews periodically the additions to the Credit universe.

b) Negative list of sectors

The debt portfolio of the captioned schemes will not invest in the securities of Airlines, Gems & Jewellery.

Further, the total exposure of the Scheme in a particular sector (excluding investments in Bank CDs, CBLO, G-Secs, TBills and AAA rated securities issued by Public Financial Institutions and Public Sector Banks) shall not exceed 30% of the net assets of the scheme. However, the Scheme can have an additional exposure to financial services sector (over and above the limit of 30%) not exceeding 10% of the net assets of the scheme in Housing Finance Companies (HFCs). The additional exposure to such securities issued by HFCs should be rated AA and above and these HFCs should be registered with National Housing Bank (NHB) and the total investment/exposure in HFCs shall not exceed 30% of the net assets of the Scheme. The sectors will be considered as per AMFI classification.

- a) In case of Certificates of Deposits, the Scheme will invest in the instruments with the highest credit rating i.e. A1+.
- b) Each of the rating categories such as AA, A etc would also include ratings with '+' and '-' i.e. AA rating will include AA+ and AA- also. The respective rating categories also include ratings with the suffix 'so'; issued by credit rating agencies for structured obligations.
- c) There will not be any variation between intended allocation and actual allocation except in following cases:
- In case of credit ratings of sub assets class, there could be a possibility of positive variation in investments towards higher credit rating of the same instruments.
- ii. At the time of building up the portfolio post NFO and toward the maturity of the Scheme, there may be a higher allocation to cash & cash equivalent including units of debt/liquid schemes
- iii. In case instruments/ securities as indicated above are not available, taking into account risk – reward analysis of such instruments/ securities, the Scheme may invest in Certificate of Deposits (CDs) of banks having highest ratings (A1+) / CBLOs/ Reverse Repo/ T-bills. Such deviations may exist till suitable securities as indicated above of desired credit quality are not
- iv. Further, the allocation may vary during the tenure of the Scheme. Some of these instances are: (i) coupon inflow; (ii) the instrument is called or bought back by the issuer (iii) in anticipation of any adverse credit event. In case of such deviations, the Scheme may invest in Bank CDs of highest rating/CBLOs/ Reverse Repo / T-Bills.
- All the investments will be based on the credit ratings available / prevalent at the time of the investments.
- e) In case, there is dual credit ratings available for the same instruments, the most conservative rating publicly available at the time of investments will be taken into consideration at the time of investments.
- f) The Scheme will invest in equity and equity related securities in the range of 15% 20% of the net assets of the Scheme. In case of any deviation from equity allocation, the Scheme may invest into CDs of highest credit rating (A1+) /CBLO / T-bills. The upper limit of 20%, for investments in options premium, if any, shall be applicable only at the time of investment. If due to market actions the value of options appreciates/ depreciates resulting in breach of the limit of 20%, the fund manager may or may not rebalance the portfolio and may run with the ongoing exposure. However, if the fund manager sells the option before expiry of the contract, the reinvestment, if any, would be subject to the maximum 20% limit on options premium.
- g) The Scheme will not invest in unrated debt instruments.

h) The Scheme may use derivatives for such purposes as maybe permitted by the Regulations, based on the opportunities available and subject to guidelines issued by SEBI from time to time.

In the event of any deviation from the asset allocation stated above except in case where the deviation is on account of the conditions stated in point C above, the Fund Manager shall rebalance the portfolio as follows:

For schemes with a tenure at inception of more than 6 months: 30 days

Policies in connection with Trading in Derivatives:

SEBI vide its circular no. MFD/CIR/011/061/2000 dated February 1, 2000 has permitted all the mutual funds to participate in the derivatives trading subject to observance of guidelines issued by SEBI in this behalf. Pursuant to this, the mutual funds may use various derivatives and hedging products from time to time, as would be available and permitted by SEBI, in an attempt to protect the value of the portfolio and enhance Unit holders' interest.

Pursuant to SEBI Circular no. DNPD/Cir 29/2005 dated September 14, 2005 and SEBI Circular No. DNPD/Cir-30/2006 dated January 20, 2006, SEBI circular No. SEBI/DNPD/Cir-31/2006 dated September 22, 2006 and SEBI Circular No. Cir/ IMD/ DF/ 11/ 2010 dated August 18, 2010 and such other circular issued by SEBI from time to time in this regard, the Fund may use derivative instruments like Interest Rate Swaps, Forward Rate Agreements, stock future or other derivative instruments for such purposes as may be permitted by regulator from time to time.

Derivative instruments may take form of stock Index futures, options on Indices, Interest rate swaps, Forward rate agreements and such other derivative instruments as may be available from time to time and appropriate for the portfolio.

The risks and returns ensuring from such investments are explained herein below:

Advantages of Equity Derivatives:

Volatility in the Indian equity markets has increased over the last few months. Derivatives provide much needed flexibility to hedge against this volatility. Some of the advantages of specific derivative products are given below:

Stock Index Futures can give exposure to the index. Appreciation in Index stocks can be effectively captured through investment in Stock Index Futures without buying individual stocks that make up the index.

The Scheme can sell futures to hedge against market movements without actually selling the underlying stocks it holds.

By buying call options on the index one can participate in the rise in the market, without actually buying individual stocks.

By buying put options on the index the Scheme can insulate the portfolio (assuming a perfect co-relation between portfolio and index - which may not be the case) from the downside risk at a small cost.

Basic Structure of an Equity Derivative Instrument

A Stock / Index Future

The Stock / Index Future is an instrument designed to give exposure to equity market indices or individual stocks. The Stock Exchange, Mumbai and The National Stock Exchange provide trading in index futures of 1, 2 and 3-month maturities. Pricing of an index future is a function of the underlying index and short-term interest rates.

Assumptions:

1 month NiftyFuture

Spot Index: 3800

Future Price on day 1: 3820 Fund buys 10,000 futures

Future price = Closing spot price = 3850

Profits for the Scheme = (3850 - 3820) X 10000 = Rs. 300,000

The net impact for the Scheme will be in terms of the difference between the closing price of the index and cost price (ignoring margins for the sake of simplicity). Thus, profit or loss for the Scheme will be the difference between the closing price (which can be higher or lower than the purchase price) and the purchase price.

Buying Options

Benefits of buying a call option

Buying a call option on a stock or index gives the owner the right, but not the obligation, to buy the underlying stock / index at the designated strike price. Here the downside risks are limited to the premium paid to purchase the option.

Illustration

If the Fund buys a 1 month call option on Hindustan Unilever at a strike of Rs. 190, the current market price being say Rs.191. The Fund will have to pay a premium of say Rs. 15 to buy this call. If the stock price goes below Rs. 190 during the tenure of the call, the Fund avoids the loss it would have incurred had it straightaway bought the stock instead of the call option. The Fund gives up the premium of Rs. 15 that has to be paid in order to protect the Fund from this probable downside. If the stock goes above Rs. 190, it can exercise its right and own Hindustan Lever at a cost price of Rs. 190, thereby participating in the upside of the stock.

Benefits of buying a put option

Buying a put option on a stock originally held by the buyer gives him/her the right, but not the obligation, to sell the underlying stock at the designated strike price. Here the downside risks are limited to the premium paid to purchase the option.

Illustration

If the Fund owns Hindustan Lever and also buys a three-month put option on Hindustan Unilever at a strike of Rs. 190, the current market price being say Rs.191. The Fund will have to pay a premium of say Rs. 12 to buy this put.

If the stock price goes below Rs. 190 during the tenure of the put, the Fund can still exercise the put and sell the stock at Rs. 190, avoiding therefore any downside on the stock below Rs. 190. The Fund incurs a loss of fixed premium of Rs. 12 that has to be paid in order to protect the Fund from this probable downside. If the stock goes above Rs. 190, say to Rs. 220, it will not exercise its option. The Fund will participate in the upside of the stock, since it can now sell the stock at the prevailing market price of Rs. 220.

Interest Rate Swaps

An interest rate swap is an agreement whereby two parties agree to exchange periodic interest payments. The amount of interest payments exchanged is based on some predetermined principal, called notional principal amount. The amount each counter party pays to the other is the agreed upon periodic interest rate multiplied by the notional principal amount. The only amount that is exchanged between the parties are the interest payment, not the notional principal amount.

A Forward Rate Agreement, on the other hand, is an agreement between two counter parties to pay or to receive the difference between an agreed fixed rate (the FRA rate) and the interest rate prevailing on a stipulated future date based on a notional amount, for an agreed period.

In the most common type of swap one party agrees to pay the other party fixed interest payments at designated dates for the life of contract. The other party agrees to make interest rate payments that float with some index.

The interest rate benchmarks that are commonly used for floating rate in an interest rate swap are those on various money market instruments. In Indian markets the benchmark most commonly used is MIBOR.

Swaps can be unwound by either reversing the original swap entered into or doing by a reverse swap with cash flows matching the original swap.

Example: Interest Rate Swap (IRS)

Suppose the Scheme has a portion of its portfolio in cash. The Fund Manager has a view that the interest rate scenario is soft and call rates are unlikely to spurt over the next three months. The fund manager would therefore prefer to receive a higher rate of return on

his cash, which he is lending in the overnight call market. In other words he would like to move to a 91 Day fixed interest rate from overnight floating rate

In the above example

Say Notional Amount : Rs.5 crores Benchmark : NSE MIBOR Tenor 91 days

Fixed Rate 6.25% At the end of 91 days

The Scheme Pays compounded call rates for 91 days, which

averages to say 5.90%

The Scheme receives fixed rate at 6.25% for 91 days.

At the end of 91 days the transaction will be settled as under:-

DWS Hybrid Fixed Term Fund receive

Fixed rate @ 6.25% for 91 days Rs. 7,79,110

DWS Hybrid Fixed Term Fund pays floating rate @ 5.90% for 91 days

amounting to

Rs. 7,35,479 Net Receivable /Settlement Value Rs. 43,631

Alternatively, usage of swap could result in a loss.

In the above example, let us assume that the Call Rate moves to 6.50%, as short term liquidity in the system hardens unexpectedly. In such a scenario, the nature of payments to be made and to be received by the Scheme would be as under:

The Scheme pays compounded Call rates for 91 days, which averages 6.50% while it receives a fixed rate payment at 6.25% for 91 days.

At the end of 91 days the transaction will be settled as under:-

Please note that the above example is hypothetical in nature and the figures are assumed.

Interest Rate Futures ("IRF")

IRF means a standardized interest rate derivative contract traded on a recognized stock exchange to buy or sell a notional security or any other interest bearing instrument or an index of such instruments or interest rates at a specified future date, at a price determined at the time of the contract.

Example of an IRF Contract Specification:

A 10 year IRF Contract will be having the following specifications:

- Underlying 10 year coupon bearing Government of India Security
- Contract Size Rs 2,00,000
- Available Contracts Monthly Contract with maximum maturity of 3 months
- Tenor The maximum maturity of the contract is 3 months
- Expiry Day Last thursday of the expiry month
- Trading Hours 9.00 a.m. to 5.00 p.m.
- Limits have been placed on gross open positions of clients across all contracts at 3% of the total open interest or Rs. 200 crores, whichever is higher.
- Quotations Similar to the price of a Gol security, having a day count convention of 30/360.

IRF for Hedging:

Interest rate futures can also be used for hedging purpose as follows:

- Hedging for increase in interest rates: In this case a decrease in the value of the portfolio can be hedged by taking a short position. If interest rates do increase, the portfolio value will decrease but the value of the futures will increase.
- Changing duration of bond portfolio: Broadly, futures can be purchased to increase the duration of the portfolio or sold to decrease the duration of the portfolio.

Example -

A debt mutual fund can effectively use IRFs to hedge from increase in interest rates. The fund has to short IRFs to hedge its position.

Note: The hedge needs to be monitored regularly to make it more effective and the hedge ratio needs to be applied to determine the number of futures contracts required to hedge the cash bond position.

A mutual fund can also hedge its corporate bond portfolio by using IRFs. However this will be a cross hedge and may not be as effective as hedging a government bond portfolio.

The Scheme may use derivative instruments primarily to protect the value of portfolio against potential risks such as interest rate risk, credit risks, reinvestment risk and liquidity risks. This protection is also known as hedge. At the same time, however, a properly correlated hedge will result in a gain in the portfolio position being offset by a loss in the hedge position. As a result, the use of derivatives could limit any potential gain from an increase in value of the position hedged. In addition, an exposure to derivatives in excess of the hedging requirement can lead to losses. IRS and FRAs do also have inherent credit and settlement risks. However, these risks are substantially reduced as they are limited to the interest streams and not the notional principal amounts.

Derivative instruments offer unique advantages like security exposures without the attendant execution and settlement risk. Derivative instruments carry a high risk return ratio. It is like a insurance policy where one has to pay the premium up-front and the benefit is contingent upon an event. Derivative instrument if used on a leveraged basis could distort the risk return ratio considerably even with a small price movement (the Scheme will not take a leveraged exposure). It requires a high level of knowledge, understanding and surveillance to control risk.

The Indian market for derivative instruments is still evolving.

The Scheme, however, will use the derivative instruments very judiciously and keep in mind the overall objective the Scheme.

In terms of SEBI Circular Cir/IMD/DF/11/2010 dated August 18, 2010, following shall be applicable with respect to investments made in derivative instruments:

- The cumulative gross exposure through equity, debt and derivative positions should not exceed 100% of the net assets of the Scheme.
- 2) Mutual Funds shall not write options or purchase instruments with embedded written options.
- 3) The total exposure related to option premium paid must not exceed 20% of the net assets of the Scheme.
- Cash or cash equivalents with residual maturity of less than 91 days may be treated as not creating any exposure.
- 5) Exposure due to hedging positions may not be included in the above mentioned limits subject to the following:
- Hedging positions are the derivative positions that reduce possible losses on an existing position in securities and till the existing position remains.
- b) Hedging positions cannot be taken for existing derivative positions. Exposure due to such positions shall have to be added and treated under limits mentioned in Point 1.
- Any derivative instrument used to hedge has the same underlying security as the existing position being hedged.
- d) The quantity of underlying associated with the derivative position taken for hedging purposes does not exceed the quantity of the existing position against which hedge has been taken.
- 6) Exposure due to derivative positions taken for hedging purposes in excess of the underlying position against which the hedging position has been taken, shall be treated under the limits mentioned in point 1.
- 7) Definition of Exposure in case of Derivative Positions: Each position taken in derivatives shall have an associated exposure as defined under. Exposure is the maximum possible loss that may occur on a position. However, certain derivative positions may theoretically have unlimited possible loss. Exposure in derivative positions shall be computed as follows:

8) Mutual Funds may enter into plain vanilla interest rate swaps for hedging purposes. The counter party in such transactions has to be an entity recognized as a market maker by RBI. Further, the value of the notional principal in such cases must not exceed the value of respective existing assets being hedged by the Scheme. Exposure to a single counterparty in such transactions should not exceed 10% of the net assets of the Scheme.

The AMC retains the right to enter into such derivative transactions as may be permitted by the SEBI regulations from time to time.

Limits for investment in derivatives instruments:-

The Schemes Participation in derivatives market shall be accordance with conditions specified in SEBI circulars nos. DNPD/Cir-29/2005 dated September 14, 2005, DNPD/Cir-30/2006 dated January 20, 2006 and SEBI/DNPD/Cir-31/2006 dated September 22, 2006, Cir/IMD/DF/11/2010 dated August 18, 2010, Further, SEBI vide circulars nos. CIR/MRD/DRMNP/35/2013 dated December 5, 2013 and CIR/MRD/DRMNP/ 2/2014 dated January 20, 2014 has prescribed the framework for trading of cash settled Interest Rate Futures (IRF) and vide SEBI CIR/MRD/DRMNP/27/2014 dated September 15, 2014 has clarified that the position limits in IRF for Mutual Funds.

Position limit for the Mutual Fund in equity index options contracts

 The Mutual Fund position limit in all equity index options contracts on a particular underlying index shall be Rs. 500 crore

- or 15% of the total open interest of the market in equity index option contracts, whichever is higher, per Stock Exchange.
- b. This limit would be applicable on open positions in all options contracts on a particular underlying index.

ii. Position limit for the Mutual Fund in equity index futures contracts:

- a. The Mutual Fund position limit in all equity index futures contracts on a particular underlying index shall be Rs. 500 crore or 15% of the total open interest in the market in equity index futures contracts, whichever is higher, per Stock Exchange.
- b. This limit would be applicable on open positions in all futures contracts on a particular underlying index.

iii. Additional position limit for hedging

In addition to the position limits at point (i) and (ii) above, Mutual Fund may take exposure in equity index derivatives subject to the following limits:

- Short positions in index derivatives (short futures, short calls and long puts) shall not exceed (in notional value) the Mutual Fund's holding of stocks.
- Long positions in index derivatives (long futures, long calls and short puts) shall not exceed (in notional value) the Mutual Fund's holding of cash, government securities, T-Bills and similar instruments.

iv. Position limit for the Mutual Fund for stock based derivatives contracts

The Mutual Fund position limit in a derivatives contract on a particular underlying stock, i.e. stock option contracts and stock futures contracts. :-

- a. For stocks having applicable market-wise position limit (MWPL) of Rs. 500 crores or more, the combined futures and options position limit shall be 20% of applicable MWPL or Rs. 300 crores, whichever is lower and within which stock futures position cannot exceed 10% of applicable MWPL or Rs. 150 crores, whichever is lower.
- b. For stocks having applicable market-wise position limit (MWPL) less than Rs. 500 crores, the combined futures and options position limit would be 20% of applicable MWPL and futures Position cannot exceed 20% of applicable MWPL or Rs. 50 crore whichever is lower.

v. Position limits for the Mutual Fund for Interest Rate Futures:

a. The gross open positions of the trading member across all contracts shall not exceed 10% of the total open interest or INR 600 crores, whichever is higher

vi. Position limits for the Scheme

The position limits for the Scheme and disclosure requirements are as follows—

- a. For stock option and stock futures contracts, the gross open position across all derivatives contracts on a particular underlying stock of a Scheme of the Mutual Fund shall not exceed the higher of: 1% of the free float market capitalisation (in terms of number of shares) or 5% of the open interest in the derivatives contracts on a particular underlying stock (in terms of number of contracts).
- This position limit shall be applicable on the combined position in all derivatives contracts on an underlying stock at a Stock Exchange.
- c. For index based contracts, the Mutual Fund shall disclose the total open interest held by its Scheme or all Schemes put together in a particular underlying index, if such open interest equals to or exceeds 15% of the open interest of all derivatives contracts on that underlying index.
- In case of interest rate swaps, the exposure to a single counterparty shall not exceed 10% of the net assets of a Fund.
- e. In case of interest rate futures, the gross open positions of the client across all contracts shall not exceed 3% of the total open interest or INR 200 crores, whichever is higher.

As and when SEBI notifies amended limits in position limits for exchange traded derivative contracts in future, the aforesaid position limits, to the extent relevant, shall be read as if they were substituted with the SEBI amended limits.

Risk Control

Since investing requires disciplined risk management, the AMC would incorporate adequate safeguards for controlling risks in the portfolio construction process.

The risk control process involves reducing risks through portfolio diversification, taking care however not to dilute returns in the process. The AMC believes that this diversification would help achieve the desired level of consistency in returns. Stock specific risk will be minimized by investing only in those companies that have been analyzed by the Investment Team at the AMC. For investments in debt securities, the AMC aims to identify securities, which offer superior levels of yield at lower levels of risks. With the aim of controlling risks, rigorous and in-depth credit evaluation of the securities proposed to be invested in, will be carried out by the investment team of the AMC. Rated Debt instruments in which the Scheme invests will be of investment grade as rated by a credit rating agency. The AMC will be guided but not limited by the ratings of Rating Agencies such as CRISIL, CARE, ICRA and Duff and Fitch or any other rating agencies that may be registered with SEBI from time to time

Portfolio Turnover

Portfolio turnover is defined as the aggregate of purchases and sales as a percentage of the corpus of the Scheme during a specified period of time. Portfolio turnover in the Scheme will be a function of market opportunities. The economic environment changes on a continuous basis and exposes debt portfolio to systematic as well as nonsystematic risk. Consequently, it is difficult to estimate with any reasonable measure of accuracy, the likely turnover in the portfolio.

The Investment Manager will endeavour to optimise portfolio turnover to optimise risk adjusted return keeping in mind the cost associated with it. A high portfolio turnover rate is not necessarily a drag on portfolio performance and may be representative of arbitrage opportunities that exist for scrips/securities held in the portfolio rather than an indication of a change in AMC's view on a scrip, etc.

Procedure and Recording of Investment Decisions:

- The Fund Manager for the Scheme is responsible for making buy / sell decisions in respect of the securities in the respective Scheme's portfolios. The investment decisions are made on a daily basis keeping in view the market conditions and all relevant aspects.
- The Board of the AMC has constituted an Investment Review Committee that will meet at periodic intervals. The Investment Review Committee, at its meetings, will review all investments made by the Scheme. The Investment review committee will consist of Chief Executive Officer, Chief Operating Officer, Chief Investment Officer, Head - Fixed Income/Fund Manager, Head-Domestic Equity, Compliance Officer & Company Secretary. The Board of the AMC may add more members to the committee as and when required
- The Investment Review Committee will also review the performance of the Scheme(s) and general market outlook and assess the investment pattern of the Scheme with regard to parameters and directions laid down in the Key Operating Procedure for Equity and Fixed Income.
- It is the responsibility of the AMC to ensure that the investments are made as per the internal and regulatory guidelines, Scheme investment objectives and in the interest of the Unitholders of the respective Scheme(s).
- The CEO/ CIO/Fund Manager will make presentations to the Board of the AMC and the Trustees periodically, indicating the performance of the Scheme(s). Among other things, the Board of AMC and Trustee will review the performance of the Scheme

in comparison to the benchmark. The Trustees reserve the right to change the benchmark for evaluation of performance of the Scheme from time to time in conformity with the Investment objectives and appropriateness of the benchmark subject to SEBI Regulations, and other prevailing guidelines, if any.

- The CEO/ CIO/ Fund Manager will bring to the notice of the AMC Board, specific factors if any, which are impacting the performance of any individual Scheme. The Board on consideration of all relevant factors may, if necessary, give appropriate directions to the AMC. Similarly, the performance of the Scheme(s) will be submitted to the Trustees. CEO/CIO/ Fund Manager will explain to the Trustees, the details on the Scheme's performance vis-à-vis the benchmark returns. The Trustees and the AMC board may also review the performance of the Scheme in the light of performance of the mutual funds industry as published from time to time by independent research agencies and financial newspapers and journals and may take corrective action in case of unsatisfactory performance.
- All investment decisions shall be recorded in terms of SEBI Circular no MFD/CIR/6/73/2000 dated July 27, 2000 or as may be revised by SEBI from time to time. Scheme / Plan. Such changes in the investment pattern will be for short term and defensive considerations.

F. FUNDAMENTAL ATTRIBUTES

Following are the Fundamental Attributes of the Scheme, in terms of Regulation 18 (15A) of the SEBI (MF) Regulations:

In accordance with Regulation 18(15A) of the SEBI (MF) Regulations, the Trustees shall ensure that no change in the fundamental attributes of the Scheme(s) and the Plan(s) / Option(s) there under or the trust or fee and expenses payable or any other change which would modify the Scheme(s) and the Plan(s) / Option(s) there under and affect the interests of Unitholders is carried out unless:

- a) A written communication about the proposed change is sent to each Unitholder and an advertisement is given in one English daily newspaper having nationwide circulation as well as in a newspaper published in the language of the region where the Head Office of the Mutual Fund is situated; and
- b) The Unit holders are given an option for a period of 30 days to exit at the prevailing Net Asset Value without any exit load.

The Composition of the index reflects the expected asset allocation of the scheme at the time of investment

The Scheme will invest in debt instruments as well as equity instruments. CRISIL Debt Hybrid 75:25 Index is the nearest representative of the asset allocation and investment universe for the Scheme.

Among other things, the Board of AMC and Trustee will review the performance of the Scheme in comparison to the benchmark. The Trustees reserve the right to change the benchmark for evaluation of performance of the Scheme from time to time in conformity with the Investment objectives and appropriateness of the benchmark subject to SEBI Regulations, and other prevailing guidelines, if any.

I. INVESTMENT LIMITATIONS / RESTRICTIONS

As per the Trust Deed read with the Regulations, the following investment restrictions apply in respect of the Scheme at the time of making investments. However, all investments by the Scheme will be made in accordance with the Investment Objective, Investment Focus, Investment Pattern described above as well as the Regulations, including Schedule VII thereof.

- 1. The Scheme shall not invest more than 15% of its NAV in Debt instruments issued by a single issuer which are rated not below investment grade by a credit rating agency authorised to carry out such activity by SEBI. Such investment limit may be extended to 20% of the NAV of the Scheme with the prior approval of the Trustees and the Board of Asset Management Company The aforesaid limit shall not be applicable for investments in government securities.
- The Scheme shall not invest more than thirty per cent of its net assets in money market instruments of an issuer. The aforesaid limit shall not be applicable for investments in Government securities, treasury bills and collateralized borrowing and lending obligations.
- 3. Transfers of investments from one Scheme to another Scheme in the same mutual fund shall be allowed only if, -

- Such transfers are done at the prevailing market price for quoted instruments on spot basis (spot basis shall have the same meaning as specified by a Stock Exchange for the spot transaction); and
- b) The securities so transferred shall be in conformity with the investment objective of the Scheme to which such transfer has been made.
- 4. The Scheme may invest in another Scheme under the same AMC or any other mutual fund without charging any fees, provided that aggregate inter Scheme investment made by all Schemes under the same management or in Schemes under the management of any other AMC shall not exceed 5% of the net asset value of the Fund.
- The Mutual Fund shall buy and sell securities on the basis of deliveries and shall in all cases of purchases, take delivery of relevant securities and in all cases of sale, deliver the securities:

Provided further that the Mutual Fund may enter into derivatives transactions in a recognized stock exchange, subject to the framework specified by SEBI.

Provided further that sale of government security already contracted for purchase shall be permitted in accordance with the guidelines issued by the RBI in this regard.

- The Fund shall get the securities purchased / transferred in the name of the Fund on account of the concerned Scheme, wherever the instruments are intended to be of long term nature.
- 7. Pending Deployment of funds of the Scheme in securities in terms of investment objective of the Scheme, can be invested in Short Term Deposits of Scheduled Commercial Banks subject to compliance with SEBI Circular no. SEBI / IMD / CIR No. 1/91171/07 dated April 16, 2007. However, Investment in short term deposit(s) with any one scheduled commercial bank including its subsidiaries should not exceed 10% of the net assets of the scheme and short term investments in Associate Banks shall not exceed 20% of total investments in short term deposits made under all the Schemes by the Mutual Fund
- 8. The Scheme shall not make any investments in;
- (a) Any unlisted security of an associate or group company of the sponsor; or
- (b) Any security issued by way of private placement by an associate or group company of the sponsor; or
- (c) The listed securities of group companies of the sponsor which is in excess of 25% of the net assets
- The Scheme shall not make any investment in Fund of Fund Scheme
- 10. No loans for any purpose may be advanced by the Fund and the Fund shall not borrow except to meet temporary liquidity needs of the Scheme for the purpose of repurchase, redemption of Units or payment of interest or dividends to Unit Holders, provided that the Fund shall not borrow more than 20% of the net assets of the Scheme and the duration of such a borrowing shall not exceed a period of six months.
- 11. If any company invests more than 5 percent of the NAV of the Scheme then investment made by any other Scheme of the Fund in that company or its subsidiaries will be disclosed in accordance with the SEBI (MF) Regulations.

- 12. The Scheme shall not invest more than 10 per cent of its NAV in the equity shares or equity related instruments of any company.
- The mutual fund under all its Schemes shall not own more than ten per cent of any company's paid up capital carrying voting rights.
- 14. The Scheme shall not invest more than 5% of its NAV in the unlisted equity shares or equity related instruments in case of open ended Scheme and 10% of its NAV in case of close ended Scheme.
- 15. Debentures, irrespective of any residual maturity period (above or below 1 year), shall attract the investment restrictions as applicable for debt instruments as specified under Clause 1 and 1A of the Seventh Schedule to the Regulations or as may be specified by SEBI from time to time.
- 16. The total exposure of the Scheme in a particular sector (excluding investments in Bank CDs, CBLO, G-Secs, TBills and AAA rated securities issued by Public Financial Institutions and Public Sector Banks) shall not exceed 30% of the net assets of the scheme. However, the Scheme can have an additional exposure to financial services sector (over and above the limit of 30%) not exceeding 10% of the net assets of the scheme in Housing Finance Companies (HFCs). The additional exposure to such securities issued by HFCs should be rated AA and above and these HFCs should be registered with National Housing Bank (NHB) and the total investment/ exposure in HFCs shall not exceed 30% of the net assets of the Scheme. The sectors will be considered as per AMFI classification.

As per the SEBI Circular No.MFD/CIR/09/014/2000 dated January 5, 2000, all investment restrictions shall be applicable at the time of making investment.

CIR/MRD/DP/31/2014 dated November 12, 2014 the investor whose transaction has been accepted by the Deutsche Mutual Fund / the AMC shall receive a confirmation by way of email and/or SMS within 5 Business Days from the date of receipt of transaction request, same will be sent to the Unit holders registered e-mail address and/or mobile number.

Thereafter, a Consolidated Account Statements (CAS) shall be issued which shall enable a single consolidated view of all the investments of an investor in Mutual Funds (MF) and securities held in demat form with the Depositories. CAS shall contain details relating to all the transactions carried out by the investor across all schemes of all mutual funds during the month and holding at the end of the month including transaction charges paid to the distributor.

However, under normal circumstances, the Mutual Fund will endeavour to despatch the redemption proceeds within 3 Business Days from the date of maturity of the Scheme.

Delay in payment of redemption / repurchase proceeds / Delay in dispatch of dividend warrant

In the event of delay / failure to dispatch the redemption/repurchase proceeds within 10 Business Days or dividend warrants within 30 days, the AMC will be liable to pay interest to the Unitholders @ 15% p.a. for the period of delay.  Additional TER up to 30 basis points will be charged on daily net assets of the scheme, if the new inflows from beyond top 15 cities are at least (a) 30% of gross new inflows in the scheme or (b) 15% of the average assets under management (year to date) of the scheme, whichever is higher.

In case inflows from beyond top 15 cities is less than the higher of (a) or (b) above, additional TER on daily net assets of the scheme shall be charged on a proportionate basis as per the formula prescribed by SEBI.

The expenses charged under this clause should be utilized for distribution expenses incurred for bringing inflows from beyond top 15 cities. The amount incurred as expense on account of inflows from such cities shall be credited back to the scheme in case the said inflows are redeemed within a period of one year from the date of investment.

II. Brokerage and transaction costs which are incurred for the purpose of execution of trade and is included in the cost of investment, not exceeding 0.12 per cent in case of cash market transactions and 0.05 per cent in case of derivatives transactions.

AMC may charge service tax on investment and advisory fees of the scheme in addition to the maximum limit of TER as per the Regulation 52(6) and (6A).

AMC may charge service tax on expenses other than investment and advisory fees of the scheme, if any within the maximum limit of TER as per the Regulation under 52(6) and (6A).

Service tax on brokerage and transaction cost paid for asset purchases, will be within the limit prescribed under regulation 52 of the Regulations.

As per SEBI Circular dated November 19, 2012 having reference number CIR/IMD/24/2012, it is clarified that the brokerage and transaction cost incurred for the purpose of execution of trade may be capitalized to the extent of 0.12 percent and 0.05 percent for cash market transactions and derivatives transactions respectively. Any payment towards brokerage and transaction cost, over and above the said 12 bps and 5bps for cash market transactions and derivatives transactions respectively may be charged to the scheme within the maximum limit of Total Expense Ratio (TER) as prescribed under regulation 52 of the SEBI (MF) Regulations. Any expenditure in excess of the said prescribed limit (including brokerage and transaction cost, if any) shall be borne by the AMC or by the trustee or sponsors.

\$Fungibility of expenses:

The expenses towards Investment Management and Advisory Fees under Regulation 52 (2) and the various sub-heads of recurring expenses mentioned under Regulation 52 (4) of SEBI (MF) Regulations are fungible in nature. Thus, there shall be no internal sub-limits within the expense ratio for expense heads mentioned under Regulation 52 (2) and (4) respectively. Further, the additional expenses under Regulation 52(6A)(c) shall also be incurred towards any of these expense heads. The purpose of the above table is to assist the Investor in understanding the various costs and expenses that an Investor in the Scheme(s) will bear directly or indirectly. The figures in the table above are estimates. The actual expenses that can be charged to the Scheme(s) will be subject to limits prescribed from time to time under the SEBI (MF) Regulations.

C. LOAD STRUCTURE

Load is an amount which is paid by the investor to subscribe to the units or to redeem the units from the Scheme. This amount is used by the AMC to pay commissions to the distributor and to take care of other marketing and selling expenses. Load amounts are variable and are subject to change from time to time. funds. Such Transaction Charge collected by the AMC will be paid to the distributor/ARN Holder (who have 'opted in' to receive the transaction charges) through whom the investment has been made. The distributors shall also have the option to opt in or opt out of levying transactions charges based on the type of product However, no Transaction Charges will be imposed for investments made directly with the Fund.

Transaction Charge shall be subject to the following as well as amendments that may be made from time to time:

- . For existing mutual fund investors, an amount of Rs.100/- per subscription of Rs.10,000/- and above.
- ii. For a new investor investing for the first time in mutual funds, an amount of Rs.150/- per subscription of Rs.10,000/- and above.
- There shall be no Transaction Charge on subscription below Rs.10,000/-
- iv. There shall be no Transaction Charge on transactions other than purchases/ subscriptions relating to new inflows.
- v. Such amount shall be deducted by the AMC from the subscription amount and paid to the distributor; and the balance amount shall be invested under the Scheme and units allotted accordingly.
- vi. The Statement of Account sent to the Unit holder shall state gross subscription less transaction charge and also show the number of units allotted against the net investment.
